

## AUSTRALIA INDIVIDUAL VISA REQUIREMENTS

#### **GENERAL REQUIREMENTS**

- 1. Duly accomplished and signed Australia Visa Application Form and Form 956-A (MPQ will assist)
- 2. Clear copy of passport data page in actual size (Original passport must be 6 months valid beyond intended stay with at least 2 blank pages)
- 3. Clear copy of previous travel within 5 years.
- 4. Clear copy of bank certificate with 6 months ADB
- 5. Clear copy of passbook
- 6. Clear copy of time deposit (if any)
- 7. Clear copy of last 6 months bank statement
- 8. Clear copy of last 6 months credit card statement
- 9. Clear copy of land title certificate
- 10. Clear copy of car registration OR/PR
- 11. Clear copy of any property documents (if any)
- 12. Clear copy of PSA marriage certificate (if traveling with spouse)
- 13. Clear copy of PSA birth certificate (if traveling with children)
- 14. Clear copy of PRC ID for professionals (Doctors, Engineers, Accountants etc.)
- 15. Clear copy of IBP ID for (lawyers)
- 16. Clear copy of alien certificate registration (ACR) for foreign passport
- 17. Clear copy of immigration certificate of residence (ICR) for foreign passport)
- 18. Clear copy of daily travel itinerary
- 19. Clear copy of round-trip flight booking confirmation
- 20. Clear copy of hotel booking confirmation

#### SPECIAL REQUIREMENTS

#### FOR EMPLOYEES

- Clear copy of employment certificate stating your position, tenure of service and income with benefits
- Clear copy of approved leave of absence
- Clear copy of company ID
- Clear copy of latest company income tax return (ITR)

#### FOR BUSINESSMEN

- Clear copy of business permit or mayor's permit
- Clear copy of DTI or SEC
- Clear copy of latest income tax return (ITR)

### FOR STUDENTS/MINORS

- Clear copy of school certificate
- Clear copy of school ID
- Clear copy of registration form
- For children travelling with one parent:
  - Duly accomplished Form 1229 by non-travelling parent, and parent's contact information and valid government-issued ID with signature.
- For children travelling with someone other than a parent:
  - Duly accomplished Form 1229 by both parents, and both parents' contact information and valid government-issued ID with signature
  - Duly accomplished Form 1257 by the person who will be responsible for you in Australia and valid government ID.

#### FOR RETIREE

- Clear copy of senior citizen ID
- Clear copy of retirement certificate (if early retiree)

### FOR FOREIGN NATIONALS

- Copy of alien certificate of registration (ACR)
- Copy of international card residence (ICR)
- Re-entry permit

If the Company will shoulder the trip

- Guarantee letter from company
- Original bank certificate and bank statements of the company (last 6 months)
- Copy of business documents and ITR of the company

All original documents must have a photocopy.

Note: additional documents may be required by the embassy without prior notice.
